This, therefore, leaves only 1 month to achieve the other activities mentioned in the TOR. Notably these are:</p> <p>1) The TOR states that the Consultant is to: a. 6	<p>Within the TOR, there are numerous references to the Defects Liability Period, however the period for this does not seem to be stated. However, we would expect this to be a minimum of 12 months.</p> <p>It would appear that there is only 1 month to achieve items 1) and 2) above, i.e. the selection and appointment of a Contractor and for the Defects Liability Period.
