AIRAC SYSTEM / AMENDMENT TO RWANDA AIP FOR THE YEAR 2016

1. Introduction

Rwanda Civil Aviation Authority (RCAA) is funded directly by charges on those it regulates or gives services to. Therefore it is necessary for RCAA to put in place charges to recover the costs of services offered.

This AIC is issued to disseminate the RCAA decision to introduce overflight and landing permit fees and is supplemental to the AIP dated December 2014.

Note: The pre-determined dates of the regulated system for publication of aeronautical information are applicable. Such publications will be issued in the form of an AIP Supplement and identified by the acronym "AIRAC". Details on information to be notified by AIRAC AIP Supplement can be found in paragraph 6.1.1 and Appendix 4, Part 1 of ICAO Annex 15 – Aeronautical Information Services.

2. Implementation date of new overflight and landing permit fees

With effect from **1 June 2016**, overflight and landing permit will be charged as per the rates below:
